This application must be filed annually until the mileage reaches 250,000+; then no further filing is required. Please use one form per vehicle. **The high mileage discount does not apply to motorcycles, motor homes, large trucks or trailers.**

### REQUIREMENTS

1. Complete and sign the application.
2. **Attach copies of proof**, i.e. oil change receipts, state inspection slips, repair bills, detailed mileage logs. **Please do not send the originals**. If you prefer, you may bring the vehicle to our office at the County Courthouse Complex on Boydton Plank Road for a visual verification of the vehicle's mileage.
3. Return the application and proof of mileage as of January 1 to the address listed above.
